1. Scope of processing and type of data

This data protection information informs you about the processing of your personal data that we process in connection with your participation in the event. 2. Purpose of data processing

We will use your e-mail address to you the newsletter of the German Society for Biomaterials (DGBM) on internal association events by e-mail in the future if you have expressly consented to such use and we have informed you of your right to object to this use at any time. In these cases, we will use your e-mail address together with your first and last name in order to be able to address you accordingly.

If the data are no longer required for the fulfillment of the aforementioned purposes, they are regularly deleted, unless their temporary further processing is necessary (intervention of legal retention periods). If the data processing is based on consent, we will erase the personal data concerned if you withdraw your consent and no other legal basis applies. If the data processing is based on our legitimate interest, we will erase the personal data concerned if you have objected to the data processing.

3. Disclosure of data to third parties

3.1 Newsletter mailing

Your data will only be passed on to third parties if this is legally permissible and necessary for the processing of the contractual relationship with you.
